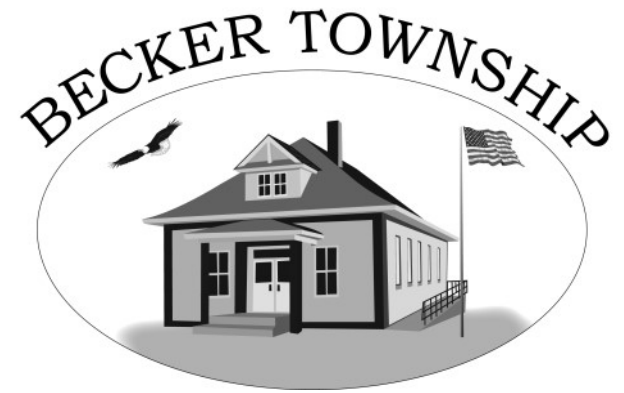

Application Submission Calendar

Whenever you plan to submit various applications (such as variances or conditional use permits) to the Township, there are four dates you need to keep in mind:

1. APPLICATION DATE (APP): 24 days prior to your public hearing, applications are due. Incomplete application do receive notice as such. Your completed application must be received the month prior to your public hearing date.

2. JOINT PLANNING BOARD (JPB): The Joint Planning Board is the board of final action. They convene two weeks after public hearings and will render the final action regarding each application.

3. PLANNING COMMISSION (PC): The Planning Commission is the body that will conduct a public hearing for your application.

4. PUBLIC NOTICE/PUBLICATION DATE (PUB): The public notice/publication date is the latest date your hearing will be advertised in the newspaper and mailed to neighbors.

Most applications go through this process. If you find something confusing or have any questions, please feel free to ask any staff members — we are here to help!
