Two physical copies of all documentation plus an electronic copy must be submitted at application. The Major Extraction Permit is allowed to be submitted at the same time the Road Use Agreement application is made.

#### PROCEDURE

The Planning Commission shall hold a Public Hearing on the proposed interim use permit request and review the request based on the following: interrelationship with the plan elements to conditions both on and off the property; conformance to the Town's Comprehensive Plan; the impact of the plan on the existing and anticipated traffic and parking conditions; the adequacy of the plan with respect to land use; pedestrian and vehicular ingress and egress; building location and height; architectural and engineering features, landscaping, lighting; provisions for utilities; site drainage; open space; loading and unloading areas; grading; signage; screening; setbacks and other related matters. The Planning Commission will make a recommendation on the application a recommendation to impose necessary conditions and safeguards on to the permit where they deem as necessary.

Notice of the Public Hearing shall be publicized in the official paper and notice shall be mailed to each owner of property situated wholly or partly within 500 feet of the property to which the interim use is related at least ten (10) days prior to the meeting. The Town of Becker shall be responsible for mailing such notices.

I HEREBY CERTIFY that I have no delinquent property taxes, special assessments, penalties, or interest due on the parcel to which the application relates. I am also aware that the property taxes which are being paid under the provisions of a court order or which are in the process of being appealed are not considered delinquent for purposes of this law if all payments under the terms of the order or appeal have been paid.
