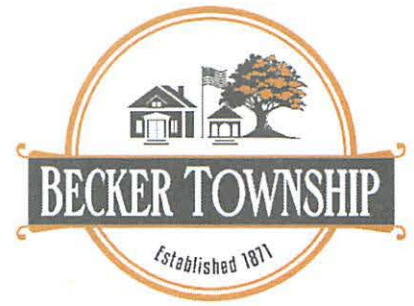


Board of Canvass Town Board Meeting
