- Road Tour was Friday will be addressing various tree trimming, headwalls and fire signs over the winter.
- Engineer Tessmer 107th Street Report based on Road Tour question regarding north ditch and secondary access near the river.
 - o Based on imagery using Google Earth
 - It appears that the area used to drain east into the Elk River.
 - In 2021, a secondary access was installed improperly. This changed the drainage patterns. Clerk to review if secondary access was permitted.
 - Secondary access needs to be dug back out. If this secondary access is desired, it requires a culvert. If there is a culvert installed, it should remedy most of the drainage issue that was mentioned.
