Residential Open Forum

County Road 93. Residents brought a petition requesting the township to accept the turnback of County Road 93 and it become a 66' wide township road. Residents wanted board to know that they didn't get all the residents signatures along this road but will do so if the board wants them.

Attorney Bourgeois reviewed steps at this point. The board will formally accept the petition by resolution and call for roadside public hearing at the next meeting if the clerk is able to determine that the petition has required information.

Motion to accept the petition submitted for possible County Road 93 takeover, pending review, by Babler. Second by Danielson. Motion Carried, All Voting in Favor. Kolbinger – aye, Wilkening – aye, Babler – aye, Danielson – aye.

Snowmobile incident, there was an accident that happened at a property in the township where a snowmobile ran over a mailbox and a fire sign. Both riders of the snowmobile were ok. The location is along a road that snowmobile club maintains for a snowmobile path. The board was shown pictures of the property where the accident had taken place. The pictures show yellow tape across the driveway along with diamond signs that the snowmobile club placed in the ditch marking the culvert location. The trail has been there for many years. The home is new. All necessary documentation required is in place.

Board comments

Mistakes happen, the snowmobile was in the right of way where allowed by state law. However, there should not be tape across the ROW. Once the snow melts the Road Supervisor or Engineer will look at the driveway to make sure that there are no headwalls at this location. The snowmobile club was present and did check with the county to ensure that the easement on that side of the road is 33ft. The clerk did as well and the snowmobile club did go out and measure where the groomer was going and it is in the correct location.

PLANNING COMMISSION/JOINT PLANNING BOARD UPDATES – Wikstrom

- This month's meeting was cancelled as there were no applications received.
 - o The previous month a Boundary Adjustment was approved.
 - o Shipping container ordinance was passed.
 - o Cannabis ordinance will be coming to the boards in the upcoming months.

ENGINEER'S REPORT – Tessmer

- o 109th St
 - In 1912 109th was established as a County Road, it is assumed that there is a 66 ft ROW. There were multiple slope easements found from past work after the road was turned back to the Township.
 - Clerk requested original records from Sherburne County, no width is discussed.

- Township Attorney stated that by use and maintenance, the 66' right of way exists, however, she recommends we go through the adjustment process to have the right of way width known and recorded as 66'.
- This is not a safe road by the road standards it is too narrow at this time.
- Survey work has already been completed on this road.
- A legal description will be presented at the March 11th annual meeting. At this meeting the electors will be asked to give the board permission to move forward with alteration of the road.
- Note: when setting the public hearing, we need to remember that the DNR needs to be notified as there is an unnamed body of water abutting.
- Did Orrock have any other records? The clerk checked with Orrock Town Clerk and she provided a copy of a traffic study she had on file, but she did not have any further road descriptions than we do. Orrock stated they had widened the road to 22', but the survey verified it was not that wide. The board can plan to do a gradual decrease to meet their road surface at the Town line.

o Bid Openings

- Legal notices were sent to the newspaper regarding the bid openings, they will publish this Saturday along with the following Saturday.
- The bid opening will happen March 17th, 2025, and will be awarded to the lowest bidder.
- The road projects were posted on Quest CDN as well, contractors can be notified of any job prospects depending on their settings that they have on this site.
- We were called by a new contractor that is in Industrial Park that was asking about bidding for some of our upcoming road projects. We notified them of the publications to the newspaper along with Quest CDN.
- o Final payment to Astec is requested from the board.
 - In the amount of \$6,087.52. The town clerk will get the correct paperwork completed to send the final payment to Astec.

Motion to Authorize final payment to Astec by Danielson. Second by Babler. Motion carried, all voting in favor. Kolbinger – aye, Wilkening – aye, Babler – aye, Danielson – aye.

o 92nd ST / 157th Ave

- The Township has documentation that they purchased land from JP Kolbinger in 1998 to move this corner and make it safer. The minutes also have the engineer reporting on the work completed. Nothing was ever recorded.
- Attorney Bourgeois recommended we go through the road alteration process to make sure everything is recorded properly. Again, we have right of way by use and maintenance, the 66' right of way exists, however, she recommends we go through the adjustment process to have the right of way width known and recorded as 66'. The old road order has the road in a different location so this will need to be addressed as well.

Wages
